A) First Party is a Higher Educational Institution named:




### **CO-OPERATION**

The Second Party will itself absorb as many candidates as possible from the trained students every year.
- 2.10. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein
- 2.11. There is no financial commitment on the part of the First Party to the Second Party i.e. **Stigmata Techno Solutions, Vembuli Amman Koil Street, Pazhavanthangal, Chennai**, to take up any programme mentioned in the MoU. ## VALIDITY




